Subject: PO No. HH-5577/QH-II/1732 dt. 25.9.03 for the procurement of 8 & 9 meters PCC poles - Blacklisting.

PO NO. HH-5577/QH-II/1732 dt. 25.9.03 has been placed on your firm for the supply of 4635 Nos. 8 meters long PCC poles and 8957 Nos. 9 meters long PCC poles.

As per the delivery schedule of the PO HH-5577 dt. 25.9.03, you were required to offer 10% of the ordered quantity of each size of pole in single lot within 45 days from the date of receipt of PO i.e. upto 15.11.03 and balance quantity upto 15.7.2004 but you did not supply 4635 Nos. 8 meters long PCC poles and 8957 Nos. 9 meters long PCC poles, despite issuance of registered first notice on 7.4.2004 to supply 4635 Nos. 8 Meters Long PCC poles & 8957 Nos. 9 Meters long PCC poles as per terms & conditions of the PO. Your firm thereby violated the terms & conditions of the agreement & committed a breach of contract, which tantamount to unethical business practice on your part & also show that you did not to honour faithfully your contractual commitment.

The reply given by you vide various letters dt. 9.11.2005, 30.12.2005 & 14.9.2007 have been considered by this office but found not satisfactory. Also, the reasons quoted by you are found not satisfactory and devoid of any substance and sustainable on the facts.

For the above act on part of your firm, it was decided to blacklist your firm and a registered A.D. notice was served upon you vide this office Memo No. Ch-95/Xen/P-III/MM dt. 28.8.07 to explain your position regarding blacklisting of your firm in the chamber of CGM/MM but you did not turn up for hearing on the stipulated date & time. This office vide letter dt. 22.10.07 again requested to deposit the due risk purchase claim of Rs. 4543980.45 (Rs. Forty Five lacs forty three thousand nine hundred eighty only)

In view of the Hon'ble court order dt. 24.8.10, the matter has been considered by competent authority and decided to blacklist your firm for a period of 3 years from the date of issue of letter for doing any business, with UHBVN.

MEMO No. 135/7 In view of above, your firm namely M/s Sindhu Durg Cement Product Pvt. Ltd. is hereby blacklisted for a period of 3 years from the date of issue of this letter for doing any business with UHBVN.


