Subject: Black listing of M/s Teracom Ltd. Noida due to non-completion of allotted work of segregation of feeders against Bid No. B-95.

Your attention is drawn to this office letter No. Ch-41/Seg/XenPD/B-95 dated 10.12.08 vide which decision regarding termination of contract was communicated besides a detailed notice prior to black listing was also given to you. This communication depicted the detailed factual position pointing out the unethical and unbusinesslike conduct of your firm. You were given an opportunity to respond to our communications referred to above. In response to which, for non-completion of work, you have pointed out some difficulties like ROW problems, public hindrances problems and space problem in switch house buildings etc. It is pointed out that the difficulties now pointed out by you were already in notice of the competent authority and effective steps were taken from time to time to remove the same. Therefore, at this stage drawing attentions towards difficulties is nothing but a flimsy excuse to cover up your inactions. Thus the explanation offered by you for non-completion of the work is not feasible of acceptance.

The most important aspect that time was the essence of the contract cannot be brushed aside. As your explanation has not been found feasible of acceptance for the reasons contained herein, your firm i.e. M/s Teracom Ltd. Noida is black listed for three years with immediate effect for conducting any business or execution of any work with the Nigam.

This is, however, without prejudice to other terms and conditions of the contract and right of the Nigam to take other action in terms of the contract besides completion of work at your risk and cost through any other agency.
