Subject: Filling up the post of Chairperson of the Consumer Grievances Redressal Forum (CGRF), Uttar Haryana Bijli Vitran Nigam.

It is proposed to fill up the post of Chairperson in Consumer Grievances Redressal Forum, UHBVN, by inviting applications from the eligible officers of the Nigam who are having following qualification and experience:

For the post of Chairperson:

- The person shall be an officer possessing a degree in Electrical/Mechanical Engineering with Ist Division and having at least 15 years experience in distribution and holding the post at least Superintending Engineer or above.

The others terms and conditions are as under:


- The Chairperson and member of the forum will be appointed for a fixed term of three years which may be extended for a further period not exceeding one year. Provided that he shall not hold office after he/she attend the age of superannuation.
- No person shall be eligible for re-appointment as Chairperson or Member.
- The Chairperson and Member shall work full-time.
- The Chairperson and Member will be governed by the terms and conditions of his/her employment in the Nigam.
- The Chairperson and Member will continue to draw the same salary as he/ she is entitled to as a regular employee of the Nigam.
- No person shall be appointed and/or be entitled to continue as a Chairperson/ Member if he/ she stands disqualified on account of his/ her:
 - a) Having been adjudged an insolvent;
 - b) Having been convicted of an offence which, in the opinion of the licensee, involves moral turpitude;
 - c) Having become physically or mentally incapable of acting as such a member;
 - d) Having acquired such financial or other interest as is likely to affect prejudicially his/ her functions as a member;

- e) Having so abused his/ her position as to render his/ her continuance in office prejudicial to public interest; or
 - f) Having been guilty of proven misbehavior.
 - g) Having joined or accepted any other gainful post/position.
- An Chairperson/ Member shall be liable to be removed from his office forthwith on account of any of the aforesaid disqualifications arising or being discovered.

Provided that no Chairperson/ Member shall be removed from his/ her office on any ground specified in the HERC Regulation-2016 notification bearing No. HERC/37/2016 dated 29th July, 2016 sub-clauses unless the Nigam has held an independent inquiry.

It is, therefore, requested that the eligible and interested officers may send their willingness for the post of Chairperson in CGRF, UHBVN within 15 days positively to this office from the issue of this memo. No application will be entertained after the prescribed period in any circumstances.
